Sub: Outcome of remote e-voting and voting at the 37th Annual General Meeting held on 23rd September, 2022.

This is with reference to our letter dated 29th August, 2022 wherein the Company had informed that the 37th Annual General Meeting (AGM) of the Company shall be held on 23rd September, 2022 at 09.00 a.m. at Hotel Ocean Inn, Plot No. 20, Devka Beach, Nani Daman (U.T.) - 396 210.

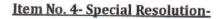
